Dr. M.L Dhawale Memorial Homoeopathic Institute, Maharashtra is functional since 2002 and has applied for permission for continuing MD (Hom) course with intake capacity of 36 seats in 06 subjects namely organon of medicine, materia medica, practice of medicine, repertory, paediatrics and psychiatry with intake capacity of 06 seats each for the academic year 2025-26.

1. Dr. M.L Dhawale Memorial Homoeopathic Institute, Maharashtra has applied for permission for sanction of MD(Hom) course with 36 seats for the academic year 2025-26. The College has submitted the Part I information in which the entire functional profile has been narrated. MARBH conducted Inspection on 13.05.2025 & 14.05.2025. The Medical Assessment and Rating Board has examined the inspection report of College as to whether the college fulfils the Minimum Essential Standards as per the prevailing regulations under clauses 26 and 28 of the NCH Act 2020.
2. Considering the inspection report MARBH has decided to issue **Permission to Dr. M.L Dhawale Memorial Homoeopathic Institute, Palghar- Boisar Road, Opp. S.T. Workshop Palghar, Maharashtra, Palghar – 401404 for conducting post graduate course MD (Hom) with 36 seats in 06 subjects namely, Organon of medicine, Materia medica, Practice of Medicine, Repertory, Pediatrics and Psychiatry with intake capacity of 06 seats each for academic year 2025-26**
3. All admissions shall be made from AIAPGET qualified candidates only. It is further informed that minimum 15% of postgraduate seats of the permitted intake capacity PG seats shall be treated as All India Quota. Counseling for seats under all India quotas shall be conducted by respective Counseling Authority of State/UT govt as designated by Central Government and counseling for the remaining 85% seats shall be conducted by the concerned counseling authority of the state/UT.
4. The Category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than AIAPGET qualified students and without permission of counseling board will not be approved by the Medical Assessment and Rating Board.


